# Yetter-Drinfeld Modules for Weak Hom-Hopf Algebras

#### Abstract

The aim of this paper is to define and study Yetter-Drinfeld modules over weak Hom-Hopf algebras. We show that the category ${ }_{H} \mathcal{W}^{\boldsymbol{y}} \mathcal{D}^{H}$ of Yetter-Drinfeld modules with bijective structure maps over weak Hom-Hopf algebras is a rigid category and a braided monoidal category, and obtain a new solution of quantum Hom-Yang-Baxter equation. It turns out that, If $H$ is quasitriangular (respectively, coquasitriangular)weak Hom-Hopf algebras, the category of modules (respectively, comodules) with bijective structure maps over $H$ is a braided monoidal subcategory of the category ${ }_{H} \mathcal{W} \mathcal{Y D}^{H}$ of Yetter-Drinfeld modules over weak Hom-Hopf algebras.


## 1. Introduction

The first examples of Hom-type algebras were related to $q$-deformations of Witt and Virasoro algebras, which play an important role in Physics, mainly in conformal field theory. The $q$-deformations of Witt and Virasoro algebras are obtained when the derivation is replaced by a $\sigma$-derivation. It was observed in the pioneering works (See [5]-[8]). Motivated by these examples and their generalization, Hartwig, Larsson and Silvestrov introduced the Hom-Lie algebras when they concerned about the $q$-deformations of Witt and Virasoro algebras in [4]. In a Hom-Lie algebra, the Jacobi identity is replaced by the so called Hom-Jacobi identity via an homomorphism. Hom-associative algebras, the corresponding structure of associative algebras, were introduced by Makhlouf and Silvestrov in [12]. The associativity of the Homalgebra is twisted by an endomorphism (here we call it the Hom structure map). The generalized notions, Hom-bialgebras, Hom-Hopf algebras were developed in [13], [14]. Caenepeel and Goyvaerts studied in [2] Hom-bialgebras and Hom-Hopf algebras from a categorical view point, and called them monoidal Hom-bialgebras and monoidal Hom-Hopf algebras respectively, which are slightly different from the above Hom-bialgebras and Hom-Hopf algebras. Thus a monoidal Hom-bialgebra is Hom-bialgebra if and only if the Hom-structure map $\alpha$ satisfies $\alpha^{2}=i d$. Yau introduced Quasitriangular Hom-bialgebras in [17]), which provided a solution of the quantum Hom-Yang-Baxter euqation, a twisted version of the quantum Yang-Baxter equation called the Hom-Yang-Baxter equation in [18]. Zhang and Wang introduced weak Hom-Hopf algebra $H$, which is generalization of both Hom-Hopf algebras and weak Hopf algebras, and

[^0]discussed the category $\operatorname{Rep}(H)$ (resp. Corep $(H)$ ) of Hom-modules (resp. Hom-comodules) with bijective Hom-structure maps, they proved that if $H$ is a (co)quasitrialgular weak Hom-bialgebra (resp. ribbon weak Hom-Hopf algebra), then $\operatorname{Rep}(H)$ (resp. Corep $(H)$ ) is a braided monoidal category (resp. ribbon category) in [19].

Makhlouf and Panaite defined and studied Yetter-Drinfeld modules over Hom bialgebras, a generalized version of bialgebras obtained by modifying the algebra and coalgebra structures by a homomorphism. Yetter-Drinfeld modules over a Hom bialgebra with bijective structure map provide solutions of the Hom-Yang-Baxter equation in [10]. It is well known that the Yetter-Drinfeld modules category of a (weak) Hopf algebra is a rigid monoidal category, and is braided. Does this result remain true in a weak HomHopf algebra? How the corresponding results appear under the condition that the associativity and coassociativity are twisted by an endomorphism? Is there any relation between this Yetter-Drinfeld modules category and module category or comodule category? This is the motivation of the present article. In order to investigate these questions, we introduce the definition of Yetter-Drinfeld modules over weak Hom-Hopf algebras, which is generalization of both weak Yetter-Drinfeld modules introduced by [3] or [15] and Hom-Yetter-Drinfeld modules introduced by [10] or [11], and consider that when the Yetter-Drinfeld modules category of a weak Hom-Hopf algebra is is a rigid monoidal category, and is braided.

To make sure that the Yetter-Drinfeld modules category of a weak Hom-Hopf algebra $H$ is a monoidal category, we need $H$ is unital and counital, and the Hom structure maps over $H$ are all bijective maps.

The paper is organized as follows. In Section 2, we recall now several concepts and results, fixing thus the terminology to be used in the rest of the paper.

In Section 3, we introduce the definition of Yetter-Drinfeld modules over weak Hom-Hopf algebras and show the category ${ }_{H} \mathcal{W} \mathcal{Y D}^{H}$ of Yetter-Drinfeld modules is a monoidal category and a rigid category.

In Section 4, we show that the category ${ }_{H} \mathcal{W} \boldsymbol{y D}^{H}$ of Yetter-Drinfeld modules is a braided monoidal category and obtain a new solution of quantum Hom-Yang-Baxter equation. It turns out that, if $H$ is a quasitriangular weak Hom-Hopf algebra, the category of left $H$-modules with bijective structure maps is a braided monoidal subcategory of the category ${ }_{H} \mathcal{W} \boldsymbol{\mathcal { D }} \mathcal{D}^{H}$ of Yetter-Drinfeld modules.

In Section 5, we find another braided monoidal category structure on the category ${ }_{H} \mathcal{W} \boldsymbol{y}_{\mathcal{D}}{ }^{H}$ of YetterDrinfeld modules, with the property that if $H$ is a coquasitriangular weak Hom-Hopf algebra, then ${ }_{H} \mathcal{W} \mathcal{Y D}^{H}$ contains the category of right $H$-comodules with bijective structure maps as a braided monoidal category.

## 2. Preliminaries

Throughout the paper, we let $\mathbb{k}$ be a fixed field and all algebras are supposed to be over $\mathbb{k}$. For the comultiplication $\Delta$ of a vector space $C$, we use the Sweedler-Heyneman's notation:

\Delta(c)=c_{1} \otimes c_{2}

for any $c \in C . \tau$ means the flip map $\tau(a \otimes b)=b \otimes a$. When we say a "Hom-algebra" or a "Hom-coalgebra", we mean the unital Hom-algebra and counital Hom-coalgebra.

In this section, we will review several definitions and notations related to weak Hom-Hopf algebras and rigid categories.

### 2.1. Hom-algebras and Hom-coalgebras.

Recall from [12] that a Hom-associative algebra is a quadruple $\left(A, \mu, \eta, \alpha_{A}\right)$, in which $A$ is a linear space, $\alpha_{A}: A \rightarrow A, \mu: A \otimes A \rightarrow A$ and $\eta: \mathbb{k} \rightarrow A$ are linear maps, with notation $\mu(a \otimes b)=a b$ and $\eta\left(1_{\mathbb{k}}\right)=1_{A}$, satisfying the following conditions, for all $a, b, c \in A$ :
(1) $\alpha_{A}(a b)=\alpha_{A}(a) \alpha(b)$;
(2) $\alpha_{A}(a)(b c)=(a b) \alpha_{A}(c)$;
(3) $\alpha_{A}\left(1_{A}\right)=1_{A}$;
(4) $1_{A} a=a 1_{A}=\alpha_{A}(a)$.

A morphism $f: A \rightarrow B$ of Hom-algebras is a linear map such that $\alpha_{B} \circ f=f \circ \alpha_{A}, f\left(1_{A}\right)=1_{B}$ and $\mu_{B} \circ(f \otimes f)=f \circ \mu_{A}$.

Let $A$ be a Hom-algebra. Recall that a left $A$-module is a triple $\left(M, \alpha_{M}, \theta_{M}\right)$, where $M$ is a $\mathbb{k}$-space, $\alpha_{M}: M \rightarrow M$ and $\theta_{M}: A \otimes M \rightarrow M$ are linear maps with notation $\theta_{M}(a \otimes m)=a \cdot m$, satisfying the following conditions, for all $a, b \in A, m \in M$ :
(1) $\alpha(a \cdot m)=\alpha(a) \cdot \alpha_{M}(m)$;
(2) $\alpha(a) \cdot(b \cdot m)=(a b) \cdot \alpha_{M}(m)$;
(3) $1_{A} \cdot m=\alpha_{M}(m)$.

A morphism $f: M \rightarrow N$ of $A$-modules is a linear map such that $\alpha_{N} \circ f=f \circ \alpha_{M}$ and $\theta_{N} \circ\left(i d_{A} \otimes f\right)=f \circ \theta_{M}$.
Recall from [14] that a Hom-coassociative coalgebra is a quadruple ( $C, \Delta, \varepsilon, \alpha_{C}$ ), in which $C$ is a linear space, $\alpha: C \rightarrow C, \Delta: C \rightarrow C \otimes C$ and $\varepsilon: C \rightarrow \mathbb{k}$ are linear maps, with notation $\Delta(c)=c_{1} \otimes c_{2}$, satisfying the following conditions for all $c \in C$ :
(1) $\Delta\left(\alpha_{C}(c)\right)=\alpha_{C}\left(c_{1}\right) \alpha\left(c_{2}\right)$;
(2) $\alpha_{C}\left(c_{1}\right) \otimes \Delta\left(c_{2}\right)=\Delta\left(c_{1}\right) \otimes \alpha_{C}\left(c_{2}\right)$;
(3) $\varepsilon \circ \alpha_{C}=\varepsilon$;
(4) $\varepsilon\left(c_{1}\right) c_{2}=c_{1} \varepsilon\left(c_{2}\right)=\alpha_{C}(c)$.

A morphism $f: C \rightarrow D$ of Hom-coalgebras is a linear map such that $\alpha_{D} \circ f=f \circ \alpha_{C}, \varepsilon_{C}=\varepsilon_{D} \circ f$ and $\Delta_{D} \circ f=(f \otimes f) \circ \Delta_{C}$.

Let $C$ be a Hom-coalgebra. Recall that a right $C$-comodule is a triple ( $M, \alpha_{M}, \rho_{M}$ ), where $M$ is a $\mathbb{k}$-space, $\alpha_{M}: M \rightarrow M$ and $\rho_{M}: M \rightarrow M \otimes C$ are linear maps with notation $\rho_{M}(m)=m_{(0)} \otimes m_{(1)}$, satisfying the following conditions for all $m \in M$ :
(1) $\rho_{M}\left(\alpha_{M}(m)\right)=\alpha_{M}\left(m_{(0)}\right) \otimes \alpha_{C}\left(m_{(1)}\right)$;
(2) $\alpha_{M}\left(m_{(0)}\right) \otimes \Delta\left(m_{(1)}\right)=\rho_{M}\left(m_{(0)}\right) \otimes \alpha_{C}\left(m_{(1)}\right)$;
(3) $\varepsilon\left(m_{1}\right) m_{0}=\alpha_{M}(m)$.

A morphism $f: M \rightarrow N$ of C-comodules is a linear map such that $\alpha_{N} \circ f=f \circ \alpha_{M}$ and $\rho_{N} \circ f=\left(i d_{C} \otimes f\right) \circ \rho_{M}$.
Recall from [19] that a weak Hom-bialgebra is a sextuple $H=\left(H, \alpha_{H}, \mu, \eta, \Delta, \varepsilon\right)$ if $\left(H, \alpha_{H}\right)$ is both a Homalgebra and a Hom-coalgebra, satisfying the following identities for any $a, b, c \in H$ :
(1) $\Delta(a b)=\Delta(a) \Delta(b)$;
(2) $\varepsilon((a b) c)=\varepsilon\left(a b_{1}\right) \varepsilon\left(b_{2} c\right), \quad \varepsilon(a(b c))=\varepsilon\left(a b_{2}\right) \varepsilon\left(b_{1} c\right)$;
(3) $\left(\Delta \otimes i d_{H}\right) \Delta\left(1_{H}\right)=1_{1} \otimes 1_{2} 1_{1}^{\prime} \otimes 1_{2}^{\prime}, \quad\left(i d_{H} \otimes \Delta\right) \Delta\left(1_{H}\right)=1_{1} \otimes 1_{1}^{\prime} 1_{2} \otimes 1_{2}^{\prime}$.

Recall from [19] that a Weak Hom-Hopf algebra is a septuple ( $\left.H, \mu, \eta, \Delta, \varepsilon, S, \alpha_{H}\right)$, in which $\left(H, \alpha_{H}\right)$ is a weak Hom-bialgebra, if $H$ endowed with a $\mathbb{k}$-linear map $S$ (the antipode), such that for any $h, g \in H$, the following conditions hold:
(1) $S \circ \alpha_{H}=\alpha_{H} \circ S$;
(2) $h_{1} S\left(h_{2}\right)=\varepsilon_{t}(h), S\left(h_{1}\right) h_{2}=\varepsilon_{S}(h)$;
(3) $S(h g)=S(g) S(h), S\left(1_{H}\right)=1_{H}$;
(4) $\Delta(S(h))=S\left(h_{2}\right) \otimes S\left(h_{1}\right), \varepsilon \circ S=\varepsilon$.

Let $\left(H, \alpha_{H}\right)$ be a weak Hom-bialgebra. Define linear maps $\varepsilon_{t}$ and $\varepsilon_{s}$ by the formula

\varepsilon_{t}(h)=\varepsilon\left(1_{1} h\right) 1_{2}, \quad \varepsilon_{s}(h)=1_{1} \varepsilon\left(h 1_{2}\right),
$$

for any $h \in H$, where $\varepsilon_{t}, \varepsilon_{s}$ are called the target and source counital maps. We adopt the notations $H_{t}=\varepsilon_{t}(H)$ and $H_{s}=\varepsilon_{s}(H)$ for their images.

Similarly, we define the linear maps $\widehat{\varepsilon_{t}}$ and $\widehat{\varepsilon_{s}}$ by the formula

for any $h \in H$. Their images are denoted by $\widehat{H}_{t}=\widehat{\varepsilon_{t}}(H)$ and $\widehat{H}_{s}=\widehat{\varepsilon_{s}}(H)$.

### 2.2. Duality and rigid categories.

Recall from [9] that let $(C, \otimes, I, a, l, r)$ be a monoidal category. $V \in C$, a left dual of $V$ is a triple $\left(V^{*}, e v_{V}, \operatorname{coev}_{V}\right)$, where $V^{*}$ is an object, $e v_{V}: V^{*} \otimes V \rightarrow I$ and $\operatorname{coev}_{V}: I \rightarrow V \otimes V^{*}$ are morphisms in $C$, satisfying

l_{V^{*}} \circ\left(e v_{V} \otimes i d_{V^{*}}\right) \circ a_{V^{*}, V, V^{*}}^{-1} \circ\left(i d_{V^{*}} \otimes \operatorname{coev}_{V}\right) \circ r_{V^{*}}^{-1}=i d_{V^{*}}

Similarly, a right dual of $V$ is a triple $\left({ }^{*} V, \widetilde{e v}_{V}, \widetilde{\operatorname{cove}}_{V}\right)$, where ${ }^{*} V$ is an object, $\widetilde{e v}_{V}: V \otimes{ }^{*} V \rightarrow I$ and $\widetilde{\operatorname{coev}}_{V}: I \rightarrow{ }^{*} V \otimes V$ are morphisms in $C$, satisfying

If each object in $C$ admits a left dual (resp. a right dual, both a left dual and a right dual), then $C$ is called a left rigid category (resp. a right rigid category, a rigid category).

## 3. Left-right Yetter-Drinfeld Modules over a Weak Hom-Hopf Algebra

Definition 3.1. Let $\left(H, \alpha_{H}\right)$ be a weak Hom-Hopf algebra. A Yetter-Drinfeld module over $H$ is a vector space ( $M, \alpha_{M}$ ), such that $M$ is a unital left $H$-module (with notation $h \otimes m \mapsto h \cdot m$ ) and a counital right $H$-comodule (with notation $m \otimes h \mapsto m_{(0)} \otimes m_{(1)}$ ) with the following compatibility condition:

(h \cdot m)_{(0)} \otimes(h \cdot m)_{(1)}=\alpha_{H}^{-1}\left(h_{21}\right) \cdot m_{(0)} \otimes\left[\alpha^{-2}\left(h_{22}\right) \alpha_{H}^{-1}\left(m_{(1)}\right)\right] S^{-1}\left(h_{1}\right), \tag{3.1}
\end{equation*}

for all $h \in H$ and $m \in M$. We denote by ${ }_{H} \mathcal{W} \boldsymbol{\mathcal { D }} \mathcal{D}^{H}$ the category of Yetter-Drinfeld modules, morphisms being the $H$-linear $H$-colinear maps.

Proposition 3.2. one has that(3.1) is equivalent to the following equations

Then we do a calculation as follows:

Using the antipode $S$ of $H$, we can provide $\mathcal{W} \mathcal{Y} \mathcal{D}(H)_{\text {f.d. }}$ with a duality.

## 4. A Braided Monoidal Category ${ }_{H} \boldsymbol{W} \boldsymbol{y} \mathcal{D}^{H} \mathbf{I}$

Proposition 4.1. Let $\left(H, \alpha_{H}\right)$ be a weak Hom-Hopf algebra. For any $\left(M, \alpha_{M}\right),\left(N, \alpha_{N}\right) \in{ }_{H} \mathcal{W} \boldsymbol{y} \mathcal{D}^{H}$, then $M \otimes_{t} N=1_{1} M \otimes 1_{2} N \in{ }_{H} \mathcal{W} \boldsymbol{Y} \mathcal{D}^{H}$ with structures:

We can make now the connection between Yetter-Drinfeld modules over weak Hom-Hopf algebras and modules over quasitriangular weak Hom-Hopf algebras.

Definition 4.5. ${ }^{[16]}$ Let $(H, \alpha)$ be a weak Hom-bialgebra. If there exists $R=R^{(1)} \otimes R^{(2)} \in \Delta^{o p}(1)\left(H \otimes_{\mathfrak{k}} H\right) \Delta(1)$, such that the following conditions hold:
(1) $(\alpha \otimes \alpha) R=R$;
(2) $R \Delta(h)=\Delta^{o p}(h) R$;
(3) there exists $\bar{R} \in \Delta(1)\left(H \otimes_{\mathfrak{k}} H\right) \Delta^{o p}(1)$, such that $R \bar{R}=\Delta^{o p}(1), \bar{R} R=\Delta(1)$;
(4) $\alpha\left(R^{(1)}\right) \otimes R_{1}^{(2)} \otimes R_{2}^{(2)}=\alpha^{-1}\left(r^{(1)} R^{(1)}\right) \otimes R^{(2)} \otimes r^{(2)}$;
(5) $R_{1}^{(1)} \otimes R_{2}^{(1)} \otimes \alpha\left(R^{(2)}\right)=r^{(1)} \otimes R^{(1)} \otimes \alpha^{-1}\left(r^{(2)} R^{(2)}\right)$,
where $h \in H, r=R=R^{(1)} \otimes R^{(2)}=r^{(1)} \otimes r^{(2)}$, then $R$ is called an $R$-matrix of $H, \bar{R}$ is called the weak inverse of $R$. $(H, R)$ is called a quasitriangular weak Hom-bialgebra.

Proposition 4.6. Let $\left(H, \alpha_{H}, R\right)$ be a quasitriangular weak Hom-Hopf algebra, then we have
(i) Let $\left(M, \alpha_{M}\right)$ be a left $H$-module with action $H \otimes M \rightarrow M, h \otimes_{t} m \mapsto h \cdot m$. Define the linear map $\rho_{M}: M \rightarrow M \otimes_{t} H, \rho_{M}(m)=m_{(0)} \otimes_{t} m_{(1)}:=R^{(2)} \cdot m \otimes_{t} \alpha_{H}\left(R^{(1)}\right)$. Then $\left(M, \alpha_{M}\right)$ with these structures is a Yetter-Drinfeld module over $H$.
(ii) Let $\left(N, \alpha_{N}\right)$ be another left $H$-module with action $H \otimes_{t} N \rightarrow N, h \otimes_{t} n \mapsto h \cdot n$, regarded as a YetterDrinfeld module as in (i), via the map $\rho_{N}: N \rightarrow N \otimes H, \rho_{N}(n)=n_{(0)} \otimes n_{(1)}:=r^{(2)} \cdot m \otimes_{t} \alpha_{H}\left(r^{(1)}\right)$. We regard $\left(M \otimes_{t} N, \alpha_{M} \otimes \alpha_{N}\right)$ as a left $H$-module via the standard action $h \cdot(m \otimes n)=h_{1} \cdot m \otimes_{t} h_{2} \cdot n$ and then we regard $\left(M \otimes_{t} N, \alpha_{M} \otimes \alpha_{N}\right)$ as a Yetter-Drinfeld module as in (i). Then this Yetter-Drinfeld module $\left(M \otimes_{t} N, \alpha_{M} \otimes \alpha_{N}\right)$ coincides with the Yetter-Drinfeld module $M \otimes_{t} N$ defined as in Proposition 4.1.

Proof. First we have to prove that $\left(M, \alpha_{M}\right)$ is a right $H$-comodule; $\rho(\alpha(m))=\alpha_{M}\left(m_{(0)}\right) \otimes \alpha\left(m_{(1)}\right)$ is easy and left to the reader, we check

$$
\begin{aligned}
\left(\alpha_{M} \otimes \Delta\right) \rho_{M}(m) & =\alpha_{M}\left(R^{(2)} \cdot m\right) \otimes \Delta\left(\alpha_{H}\left(R^{(1)}\right)\right) \\
& =\alpha_{H}\left(R^{(2)}\right) \cdot \alpha_{M}(m) \otimes \alpha_{H}\left(R_{1}^{(1)}\right) \otimes \alpha_{H}\left(R_{2}^{(1)}\right) \\
& =r^{(2)} R^{(2)} \cdot \alpha_{M}(m) \otimes \alpha_{H}^{2}\left(r^{(1)}\right) \otimes \alpha_{H}^{2}\left(R^{(1)}\right) \\
& =\alpha_{H}\left(r^{(2)}\right) \cdot\left(R^{(2)} \cdot m\right) \otimes \alpha_{H}^{2}\left(r^{(1)}\right) \otimes \alpha_{H}^{2}\left(R^{(1)}\right) \\
& =r^{(2)} \cdot\left(R^{(2)} \cdot m\right) \otimes \alpha_{H}\left(r^{(1)}\right) \otimes \alpha_{H}^{2}\left(R^{(1)}\right) \\
& =\rho_{M}\left(R^{(2)} \cdot m\right) \otimes \alpha_{H}^{2}\left(R^{(1)}\right) \\
& =\left(\rho_{M} \otimes \alpha_{M}\right) \rho_{M}(m) .
\end{aligned}
$$

Now we check the Yetter-Drinfeld condition (3.3):

$$
\begin{aligned}
\left(h_{2} \cdot m\right)_{(0)} \otimes\left(h_{2} \cdot m\right)_{(1)} \alpha_{H}^{2}\left(h_{1}\right) & =R^{(2)} \cdot\left(h_{2} \cdot m\right) \otimes \alpha_{H}\left(R^{(1)}\right) \alpha_{H}^{2}\left(h_{1}\right) \\
& =\alpha_{H}\left(R^{(2)}\right) \cdot\left(h_{2} \cdot m\right) \otimes \alpha_{H}^{2}\left(R^{(1)}\right) \alpha_{H}^{2}\left(h_{1}\right) \\
& =\left(R^{(2)} h_{2}\right) \cdot \alpha_{M}(m) \otimes \alpha_{H}^{2}\left(R^{(1)} h_{1}\right) \\
& =\left(h_{1} R^{(2)}\right) \cdot \alpha_{M}(m) \otimes \alpha_{H}^{2}\left(h_{2} R^{(1)}\right) \\
& =\alpha_{H}\left(h_{1}\right) \cdot\left(R^{(2)} \cdot m\right) \otimes \alpha_{H}^{2}\left(h_{2}\right) \alpha_{H}^{2}\left(R^{(1)}\right) \\
& =\alpha_{H}\left(h_{1}\right) \cdot m_{(0)} \otimes \alpha_{H}^{2}\left(h_{2}\right) \alpha_{H}\left(m_{(1)}\right) .
\end{aligned}
$$

(ii) We only need to prove that the two comodule structures on $M \otimes_{t} N$ coincide, that is, for all $m \in M$ and $n \in N$,

$$
m_{(0)} \otimes n_{(0)} \otimes \alpha_{H}^{-2}\left(n_{(1)} m_{(1)}\right)=R^{(2)} \cdot(m \otimes n) \otimes \alpha_{H}\left(R^{(1)}\right),
$$

that is

$$
R^{(2)} \cdot m \otimes r^{(2)} \cdot n \otimes \alpha_{H}^{-2}\left(\alpha_{H}\left(r^{(2)}\right) \alpha_{H}\left(R^{(2)}\right)\right)=R_{1}^{(2)} \cdot m \otimes R_{2}^{(2)} \cdot n \otimes \alpha_{H}\left(R^{(1)}\right),
$$

which is equivalent to

$$
\alpha_{H}\left(R^{(2)}\right) \cdot m \otimes \alpha_{H}\left(r^{(2)}\right) \cdot n \otimes r^{(2)} R^{(2)}=R_{1}^{(2)} \cdot m \otimes R_{2}^{(2)} \cdot n \otimes \alpha_{H}\left(R^{(1)}\right) .
$$

Proposition 4.7. Let $\left(H, \alpha_{H}, R\right)$ be a quasitriangular weak Hom-Hopf algebra. Denote by $\operatorname{Rep}(H)$ the category whose objects are left $H$-modules and whose morphisms are $H$-linear maps. Then $\operatorname{Rep}(H)$ is a braided monoidal subcategory of ${ }_{H} \mathcal{W} \boldsymbol{y} \mathcal{D}^{H}$, with tensor product defined as in Proposition 4.1, associativity constraints defined by the formula $a_{M, N, P}((m \tilde{\otimes} n) \tilde{\otimes} p)=\alpha_{M}^{-1}(m) \tilde{\otimes}\left(n \tilde{\otimes} \alpha_{P}(p)\right)$ for any $M, N, P \in \operatorname{Rep}(H)$, and braiding $c_{M, N}: M \otimes_{t} M \rightarrow N \otimes_{t} M, m \otimes_{t} n \mapsto R^{(2)} \cdot \alpha_{N}^{-1}(n) \otimes_{t} R^{(1)} \cdot \alpha_{M}^{-1}(m)$, with inverse $c_{M, N}^{-1}: N \otimes_{t} M \rightarrow$ $M \otimes_{t} M, n \otimes_{t} m \mapsto \bar{R}^{(1)} \cdot \alpha_{M}^{-1}(m) \otimes_{t} \bar{R}^{(2)} \cdot \alpha_{N}^{-1}(n)$, for any $\left(M, \alpha_{M}\right),\left(N, \alpha_{N}\right) \in \operatorname{Rep}(H)$.

## 5. A Braided Monoidal Category ${ }_{H} \boldsymbol{W} \boldsymbol{y} \mathcal{D}^{H}$ II

Modules over quasitriangular weak Hom-Hopf algebras become Yetter-Drinfeld modules over weak Hom-Hopf algebras are proved in Section 4. Similarly, comodules over coquasitriangular weak Hom-Hopf algebras become Yetter-Drinfeld modules over weak Hom-Hopf algebras; inspired by this, we can introduce a second braided monoidal category structure on $H_{H} \mathcal{W} \mathcal{D}^{H}$. We include these facts here for completeness. Each of the next results is the analogue of a result in Section 4; their proofs are similar to those of their analogues and are left to the reader.

Proposition 5.1. Let $\left(H, \alpha_{H}\right)$ be a weak Hom-Hopf algebra.
(i) Let $\left(M, \alpha_{M}\right),\left(N, \alpha_{N}\right) \in_{H} \mathcal{W} \boldsymbol{Y} \mathcal{D}^{H}$, with notation as above, and the tensor product $M \tilde{\otimes} N$ is obtained by

$$
M \tilde{\otimes} N=\left\{m \tilde{\otimes} n=m_{0} \otimes_{k} n_{0} \varepsilon\left(m_{1} n_{1}\right) \mid m \in M, n \in N\right\},
$$

with structures:

$$
\begin{aligned}
& h \cdot(m \tilde{\otimes} n)=\alpha_{H}^{-2}\left(h_{1}\right) \cdot m \tilde{\otimes} \alpha_{H}^{-2}\left(h_{2}\right) \cdot n, \\
& m \tilde{\otimes} n \mapsto(m \tilde{\otimes} n)_{(0)} \otimes(m \tilde{\otimes} n)_{(1)}=\left(m_{(0)} \tilde{\otimes} n_{(0)}\right) \tilde{\otimes} n_{(1)} m_{(1)} .
\end{aligned}
$$

(ii) $H_{H} \mathcal{W} \mathcal{Y} \mathcal{D}^{H}$ is a braided monoidal category, with tensor product $\tilde{\otimes}$ as in (i) and associativity constraints $a_{M, N, P}$ and quasi-braiding $c_{M, N}$ defined as follows: for any $\left(M, \alpha_{M}\right),\left(N, \alpha_{N}\right),\left(P, \alpha_{P}\right) \in_{H} \mathcal{W} \boldsymbol{Y} \mathcal{D}^{H}$, define an associativity constraint by

$$
\begin{gathered}
a_{M, N, P}((m \tilde{\otimes} n) \tilde{\otimes} p)=\alpha_{M}^{-1}(m) \tilde{\otimes}\left(n \tilde{\otimes} \alpha_{P}(p)\right), m \in M, n \in N, p \in P, \\
c_{M, N}: M \tilde{\otimes} N \rightarrow M \tilde{\otimes} M, c_{M, N}(m \tilde{\otimes} n)=\alpha_{N}^{-1}\left(n_{(0)}\right) \tilde{\otimes} \alpha_{M}^{-1}\left(\alpha_{H}^{-1}\left(n_{(1)}\right) \cdot m\right) .
\end{gathered}
$$

with inverse

$$
c_{M, N}^{-1}(n \tilde{\otimes} m)=\alpha_{M}^{-1}\left(\alpha_{H}^{-1}\left(S\left(n_{(1)}\right)\right) \cdot m\right) \tilde{\otimes} \alpha_{N}^{-1}\left(n_{(0)}\right)
$$

Definition 5.2. ${ }^{[16]}$ Let $(H, \alpha)$ be a weak Hom-bialgebra, if there is a linear map $\sigma: H \otimes_{\mathbb{k}} H \rightarrow \mathbb{k}$, such that the following conditions hold:
(1) $\sigma(a, b)=\varepsilon\left(b_{1} a_{1}\right) \sigma\left(a_{2}, b_{2}\right) \varepsilon\left(a_{3} b_{3}\right)$;
(2) $\sigma\left(a_{1}, b_{1}\right) a_{2} b_{2}=b_{1} a_{1} \sigma\left(a_{2}, b_{2}\right)$;
(3) there exists $\sigma^{\prime} \in \operatorname{hom}_{\mathbb{k}}(H \otimes H, \mathbb{k})$, such that $\sigma\left(a_{1}, b_{1}\right) \sigma^{\prime}\left(a_{2}, b_{2}\right)=\varepsilon(a b)$, and $\sigma^{\prime}\left(a_{1}, b_{1}\right) \sigma\left(a_{2}, b_{2}\right)=\varepsilon(b a)$;
(4) $\sigma(\alpha(a), \alpha(b))=\sigma(a, b)$;
(5) $\sigma(\alpha(a), b c)=\sigma\left(a_{1}, \alpha(c)\right) \sigma\left(a_{2}, \alpha(b)\right)$;
(6) $\sigma(a b, \alpha(c))=\sigma\left(\alpha(a), c_{1}\right) \sigma\left(\alpha(b), c_{2}\right)$,
where $a, b, c \in H$, then $\sigma$ is called an coquasitriangular form of $H, \sigma^{\prime}$ is called the weak convolution inverse of $\sigma$. $(H, \sigma)$ is called a coquasitriangular weak Hom-bialgebra.

Proposition 5.3. Let $\left(H, \alpha_{H}, \sigma\right)$ be a coquasitriangular weak Hom-Hopf algebra, then we have
(i) Let $\left(M, \alpha_{M}\right)$ be a left $H$-comodule with coaction $M \rightarrow M \tilde{\otimes} H, \rho_{M}(m)=m_{(0)} \tilde{\otimes} m_{(1)}$. Define the linear $\operatorname{map} H \otimes M \rightarrow M, h \tilde{\otimes} m \mapsto h \cdot m:=\sigma\left(\alpha_{H}(h), m_{(1)}\right) m_{(0)}$. Then $\left(M, \alpha_{M}\right)$ with these structures is a Yetter-Drinfeld module over $H$.
(ii) Let $\left(N, \alpha_{N}\right)$ be another left $H$-comodule with coaction $N \rightarrow N \tilde{\otimes} H, \rho_{N}(n)=n_{(0)} \tilde{\otimes} n_{(1)}$. Define the linear map $H \otimes N \rightarrow N, h \otimes \tilde{\otimes} n \mapsto h \cdot n:=\sigma\left(\alpha_{H}(h), n_{(1)}\right) n_{(0)}$. We regard ( $M \otimes \tilde{\otimes} N, \alpha_{M} \otimes \alpha_{N}$ ) as a left $H$-module via the
standard action $h \cdot(m \tilde{\otimes} n)=\alpha_{H}^{-2}\left(h_{1}\right) \cdot m \tilde{\otimes} \alpha_{H}^{-2}\left(h_{2}\right) \cdot n$ and then we regard $\left(M \tilde{\otimes} N, \alpha_{M} \otimes \alpha_{N}\right)$ as a Yetter-Drinfeld module as in (i). Then this Yetter-Drinfeld module ( $M \otimes \tilde{\otimes} N, \alpha_{M} \otimes \alpha_{N}$ ) coincides with the Yetter-Drinfeld module $M \tilde{\otimes} N$ defined as in Proposition 5.1.

Theorem 5.4. Let $\left(H, \alpha_{H}, \sigma\right)$ be a coquasitriangular weak Hom-Hopf algebra. Denote by Corep $(H)$ the category whose objects are right $H$-comodules $\left(M, \alpha_{M}\right)$ and morphisms are morphisms of right $H$ comodules. Then $\operatorname{Corep}(H)$ is a braided monoidal subcategory of ${ }_{H} \boldsymbol{W} \boldsymbol{\mathcal { V }} \mathcal{D}^{H}$, with tensor product defined as in Proposition 5.1, associativity constraints defined by the formula $a_{M, N, P}((m \tilde{\otimes} n) \tilde{\otimes} p)=\alpha_{M}^{-1}(m) \tilde{\otimes}\left(n \tilde{\otimes} \alpha_{P}(p)\right)$ for any $M, N, P \in \operatorname{Corep}(H)$, and braiding $c_{M, N}: M \tilde{\otimes} N \rightarrow N \tilde{\otimes} M, m \tilde{\otimes} n \mapsto \alpha_{M}^{-1}\left(n_{0}\right) \tilde{\otimes} \alpha_{M}^{-1}\left(m_{0}\right) \sigma\left(m_{1}, n_{1}\right)$, with inverse $c^{-} 1_{M, N}: N \tilde{\otimes} M \rightarrow M \tilde{\otimes} N, \quad n \tilde{\otimes} m \mapsto \alpha_{M}^{-1}\left(m_{0}\right) \tilde{\otimes} \alpha_{N}^{-1}\left(n_{0}\right) \sigma^{\prime}\left(m_{1}, n_{1}\right)$, for any $\left(M, \alpha_{M}\right),\left(N, \alpha_{N}\right) \in \operatorname{Corep}(H)$.
