# Laguerre Hypersurfaces With Definite Laguerre Tensor

#### Abstract

M^{n-1} \rightarrow \mathbb{R}^{n}\) be an umbilical free hypersurface with non-zero principal curvatures. Then $x$ is associated with a Laguerre metric $\mathbf{g}$, a Laguerre tensor $\mathbf{L}$, a Laguerre form $\mathbf{C}$, and a Laguerre second fundamental form $\mathbf{B}$, which are invariants of $x$ under Laguerre transformation group. In this paper, we will study the Laguerre hypersurface with parallel Laguerre form and nonnegative or non-positive Laguerre tensor.


## 1. Introduction

Let $U \mathbb{R}^{n}$ be the unit tangent bundle over $\mathbb{R}^{n}$. An oriented sphere in $\mathbb{R}^{n}$ centered at $p$ with radius $r$ can be regarded as the "oriented sphere" $\{(x, \xi) \mid x-p=r \xi\}$ in $U \mathbb{R}^{n}$, where $x$ is the position vector and $\xi$ is the unit normal of the sphere. An oriented hyperplane in $\mathbb{R}^{n}$ with constant unit normal $\xi$ and constant real number $c$ can be regarded as the "oriented hyperplane" $\{(x, \xi) \mid x \cdot \xi=c\}$ in $\mathbb{R}^{n}$. A diffeomorphism $\phi: U \mathbb{R}^{n} \rightarrow U \mathbb{R}^{n}$ which takes oriented spheres to oriented spheres, oriented hyperplanes to oriented hyperplanes, preserving the tangential distance of any two spheres, is called a Laguerre transformation. All Laguerre transformations in $U \mathbb{R}^{n}$ form a group of dimension $(n+1)(n+2) / 2$, called the Laguerre transformation group.

An oriented hypersuface $x: M \rightarrow \mathbb{R}^{n}$ can be identified as the submanifold $(x, \xi): M \rightarrow U \mathbb{R}^{n}$, where $\xi$ is the unit normal of $x$. Two hypersurfaces $x, x^{*}: M \rightarrow \mathbb{R}^{n}$ are called Lagrerre equivalent, if there is a Laguerre transformation $\phi: U \mathbb{R}^{n} \rightarrow U \mathbb{R}^{n}$ such that $\left(x^{*}, \xi^{*}\right)=\phi \circ(x, \xi)$. In Laguerre geometry one studies properties and invareants of hyperfaces in $\mathbb{R}^{n}$ under the Laguerre transformation group.

Laguerre geometry of surfaces in $\mathbb{R}^{3}$ has been developed by Blaschke and his school(see[1]). Recently, there has been some renewed interest in Laguerre geometry (see[2-4, 6, 8-11]).

In [7], Li and Wang studied Laguerre differential geometry of oriented hypersurfaces in $\mathbb{R}^{n}$. For any umbilical-free hypersurface $x: M \rightarrow \mathbb{R}^{n}$ with non-zero principal curvatures, Li and Wang defined the Laguerre invariant metric $\mathbf{g}$, the Laguerre second fundamental form $\mathbf{B}$, the Laguerre form $\mathbf{C}$ and the

[^0]Laguerre tensor $\mathbf{L}$ on $M$, and showed that $\{\mathbf{g}, \mathbf{B}\}$ is a complete Laguerre invariant system for hypersurfaces in $\mathbb{R}^{n}$ with $n \geq 4$. In the case $n=3$, a complete Laguerre invariant system for surfaces in $\mathbb{R}^{3}$ is given by $\{\mathbf{g}, \mathbf{B}, \mathbf{L}\}$. Based on this foundation, in [5], Li et al. gave the classification of hypersurfaces with constant Laguerre eigenvalues and vanishing Laguerre form in $\mathbb{R}^{n}$.

The Laguerre tensor is said to be nonnegative or non-positive, if all the eigenvalues of Laguerre tensor are nonnegative or non-positive. As we know, under the condition of constant Laguerre eigenvalues, vanishing Laguerre form is equivalent to parallel Laguerre form. Thus, it is very interesting and important to study hypersurfaces with parallel Laguerre form and nonnegative or non-positive Laguerre tensor.

In this paper, we will prove the following result:
Theorem 1.1. Let $x: M^{n-1} \rightarrow \mathbb{R}^{n}$ be an umbilical free hypersurface with non-zero principal curvatures. If the Laguerre form $\mathbf{C}$ is parallel and the Laguerre tensor $\mathbf{L}$ is nonnegative or non-positive, then the Laguerre tensor $\mathbf{L}$ is must identically zero, which means that $M^{n-1}$ is laguerre equivalent to an open subset of the hypersurface: the image of $\tau$ of the oriented hypersurface $x: \mathbb{R}^{n-1} \rightarrow \mathbb{R}_{0}^{n}$ given by the following example 3.1 in Section 3.

We organize the paper as follows. In Section 2 we give Lguerre invariants for hypersurfaces in $\mathbb{R}^{n}$. In Section 3, an interesting example is presented. Finally, in Section 4, we prove the Main Theorem.

## 2. Laguerre geometry of hypersurfaces in $R^{n}$

In this section we review the Laguerre invariants and structure equations for hypersurfaces in $\mathbb{R}^{n}$. For the detail we refer to [7].

Let $\mathbb{R}_{2}^{n+3}$ be the space $\mathbb{R}^{n+3}$ equipped with the inner product

Let $C^{n+2}$ be the light-cone in $\mathbb{R}^{n+3}$ given by $C^{n+2}=\left\{X \in R_{2}^{n+3} \mid\langle X, X\rangle=0\right\}$. Let $L G$ be the subgroup of orthogonal group $O(n+1,2)$ on $R_{2}^{n+3}$ given by

L G=\{T \in O(n+1,2) \mid \varsigma T=\varsigma\}
$$

where $\varsigma=(1,-1,0,0)$, where $0 \in \mathbb{R}^{n}$, is a light-like vector in $\mathbb{R}_{2}^{n+3}$.
Let $x: M \rightarrow \mathbb{R}^{n}$ be an umbilical free hypersurface with non-zero principal curvatures. Let $\xi: M \rightarrow \mathbb{S}^{n-1}$ be its unit normal. Let $\left\{e_{1}, e_{2}, \cdots, e_{n-1}\right\}$ be the orthonormal basis for TM with respect to $d x \cdot d x$, consisting of unti principal vectors. We write the structure equations of $x: M \rightarrow \mathbb{R}^{n}$ by

where $k_{i} \neq 0$ is the principal curvature corresponding to $e_{i}$. Let

r_{i}=\frac{1}{k_{i}}, r=\frac{r_{1}+r_{2}+\cdots+r_{n-1}}{n-1}
$$

be the curvature radius and mean curvature radius of $x$, respectively. We define Laguerre position vector of $x$ by

Y=\rho(x \cdot \xi,-x \cdot \xi, \xi, 1): M \rightarrow C^{n+2} \subset R_{2}^{n+3}
$$

where $\rho=\sqrt{\sum_{i}\left(r_{i}-r\right)^{2}}>0$.
Theorem 2.1. Let $x, \tilde{x}: M \rightarrow \mathbb{R}^{n}$ be two umbilical oriented hypersurfaces with non-zero principal curvatures. Then $x$ and $\tilde{x}$ are Laguerre equivalent if and only if there exists $T \in L G$ such that $\tilde{Y}=Y T$.

From the theorem we know that

\mathbf{g}=\langle d Y, d Y\rangle=\rho^{2} d \xi \cdot d \xi=\rho^{2} I I I
$$

is a Laguerre invariant metric, where $I I I$ is the third fundamental form of $x$. we call $\mathbf{g}$ the Laguerre metric of $x$. Let $\Delta$ be the Laplacian operator of $\mathbf{g}$, then we have

From (1) we get

Let $\left\{E_{1}, E_{2}, \cdots, E_{n-1}\right\}$ be an orthonormal basis for $g=\langle d Y, d Y\rangle$ with dual basis $\left\{\omega_{1}, \omega_{2}, \cdots, \omega_{n-1}\right\}$ and write $Y_{i}=E_{i}(Y), 1 \leq i \leq n-1$. Then we have the following orthogonal decomposition,

R_{2}^{n+3}=\operatorname{Span}\{Y, N\} \oplus \operatorname{Span}\left\{Y_{1}, Y_{2}, \cdots, Y_{n-1}\right\} \oplus \operatorname{span}\{\eta, \varsigma\} .

We call $\left\{Y, N, Y_{1}, \cdots, Y_{n-1}, \eta, \varsigma\right\}$ a Laguerre moving frame in $R_{2}^{n+3}$ of $x$. By taking derivatives of this frame we obtain the following structure equations:

From these equations we obtain the following basic Laguerre invariants: the Laguerre metric $\mathbf{g}=\langle d Y, d Y\rangle$, the Laguerre second fundamental form $\mathbf{B}=\sum_{i j} B_{i j} \omega_{i} \otimes \omega_{j}$, the Laguerre tensor $\mathbf{L}=\sum_{i j} L_{i j} \omega_{i} \otimes \omega_{j}$ and the Laguerre form $\mathbf{C}=\sum_{i} C_{i} \omega_{i}$, where $L_{i j}=L_{j i}, B_{i j}=B_{j i}$.

Define the covariant derivatives of $\mathbf{L}, \mathbf{B}$ and $\mathbf{C}$ by

Exterior differentiation of the structure equations gives their integrability conditions:

Moreover, we have the following identities(see[7]):

is the normalized scalar curvature.
In the case $n \geq 4$, we know from (13) and (16) that $C_{i}$ and $L_{i j}$ are completely determined by the Laguerre invariants $\{\mathbf{g}, \mathbf{B}\}$, thus we get

Theorem 2.2. Two umbilical free oriented hypersurfaces in $R^{n}(n>3)$ with non-zero principal curvatures are Laguerre equivalent if and only if they have the same Laguerre metric $\mathbf{g}$ and Laguerre second fundamental form $\mathbf{B}$.

In the case $n=3$, a complete Laguerre invariant system for surfaces in $R^{3}$ is given by $\{\mathbf{g}, \mathbf{B}, \mathbf{L}\}$.

## 3. example

The following example is taken from [4], we will show that the Laguerre second fundamental form $\mathbf{B}$ is parallel, the Laguerre form $\mathbf{C}$ and Laguerre tensor $\mathbf{L}$ vanish.

Example 3.1 ([4]). For any positive integers $m_{1}, \ldots, m_{s}$ with $m_{1}+m_{2}+\ldots+m_{s}=n-1$ and any non-zero constants $\lambda_{1}, \ldots, \lambda_{s}$, we define $x: \mathbb{R}^{n-1} \rightarrow \mathbb{R}_{0}^{n}$ to be a space-like oriented hypersurface in $\mathbb{R}_{0}^{n}$ given by

x=\left(\frac{\lambda_{1}\left|u_{1}\right|^{2}+\lambda_{2}\left|u_{2}\right|^{2}+\ldots+\lambda_{s}\left|u_{s}\right|^{2}}{2}, u_{1}, u_{2}, \ldots, u_{s}, \frac{\lambda_{1}\left|u_{1}\right|^{2}+\lambda_{2}\left|u_{2}\right|^{2}+\ldots+\lambda_{s}\left|u_{s}\right|^{2}}{2}\right),
$$

where $\left(u_{1}, u_{2}, \ldots, u_{s}\right) \in \mathbb{R}^{m_{1}} \times \mathbb{R}^{m_{2}} \times \ldots . \times \mathbb{R}^{m_{s}}=\mathbb{R}^{n-1}$ and $\left|u_{i}\right|^{2}=u_{i} \cdot u_{i}, i=1, \ldots, s$. Then $\tau \circ(x, \xi)=\left(x^{\prime}, \xi^{\prime}\right): \mathbb{R}^{n-1} \rightarrow$ $U \mathbb{R}^{n}$, and we get the hypersurfaces $x^{\prime}: \mathbb{R}^{n-1} \rightarrow \mathbb{R}^{n}$.

Let $\mathbb{R}_{1}^{n+1}$ be the Minkowski space with the inner product

\end{equation*}

Let $v=(1,0,1)$ be the light-like vector in $\mathbb{R}_{1}^{n+1}$ with $\mathbf{0} \in \mathbb{R}^{n-1}$. Let $\mathbb{R}_{0}^{n}$ be the degenerate hyperplane in $\mathbb{R}_{1}^{n+1}$ defined by

\mathbb{R}_{0}^{n}=\left\{X \in \mathbb{R}_{1}^{n+1}:\langle X, v\rangle=0\right\} . \tag{18}
\end{equation*}

We define

U \mathbb{R}_{0}^{n}=\left\{(x, \xi) \in \mathbb{R}_{1}^{n+1} \times \mathbb{R}_{1}^{n+1}:\langle x, v\rangle=0,\langle\xi, \xi\rangle=0,\langle\xi, v\rangle=1\right\} \tag{19}
\end{equation*}
$$

and $\tau: U \mathbb{R}_{0}^{n} \rightarrow U \mathbb{R}^{n}$ given by

where $x=\left(x_{1}, x_{0}, x_{1}\right) \in \mathbb{R} \times \mathbb{R}^{n-1} \times \mathbb{R}, \xi=\left(\xi_{1}+1, \xi_{0}, \xi_{1}\right) \in \mathbb{R} \times \mathbb{R}^{n-1} \times \mathbb{R}$ and

x^{\prime}=\left(-\frac{x_{1}}{\xi_{1}}, x_{0}-\frac{x_{1}}{\xi_{1}} \xi_{0}\right), \xi^{\prime}=\left(1+\frac{1}{\xi_{1}}, \frac{x_{0}}{\xi_{1}}\right) . \tag{21}
\end{equation*}

Let $x: M \rightarrow \mathbb{R}_{0}^{n}$ be a space-like oriented hypersurface in the degenerate hyperplan $\mathbb{R}_{0}^{n}$. Let $\xi$ be the unique vector in $\mathbb{R}_{1}^{n+1}$ satisfying

\langle\xi, d x\rangle=0, \quad\langle\xi, \xi\rangle=0, \quad\langle\xi, v\rangle=1 .
$$

From $\tau(x, \xi)=\left(x^{\prime}, \xi^{\prime}\right) \in U \mathbb{R}^{n}$, we get a hypersurface $x: M \rightarrow \mathbb{R}^{n}$.
Let $x: M \rightarrow \mathbb{R}_{0}^{n}$ be a space-like oriented hypersurface in the degenerate hyperplane $\mathbb{R}_{0}^{n}$. Let $\xi$ be the unique vector in $\mathbb{R}_{1}^{n+1}$ satisfying

\langle\xi, d x\rangle=0, \quad\langle\xi, \xi\rangle=0, \quad\langle\xi, v\rangle=1
$$

We define the shape operator $\mathbf{S}: T M \rightarrow T M$ by $d \xi=-d x \circ \mathbf{S}$. Since $\mathbf{S}$ is self-adjoint, all eigenvalues $\left\{k_{i}\right\}$ of $\mathbf{S}$ are real. Let $\left\{e_{1}, e_{2}, \ldots e_{n-1}\right\}$ be the orthonormal basis for $T M$ with respect to $d x \cdot d x$, consisting of eigenvectors of $\mathbf{S}$. We write the structure equation of $x: M \rightarrow \mathbb{R}_{0}^{n}$ by

e_{j}\left(e_{i}(x)\right)=\sum_{k} \Gamma_{i j}^{k} e_{k}(x)+k_{i} \delta_{i j} v, \quad e_{i}(\xi)=-k_{i} e_{i}(x), \quad 1 \leq i, j, k \leq n-1
$$

We assume that $k_{i} \neq 0$, and we define $r_{i}=1 / k_{i}$ as the curvature radius of $x$ and $r=\left(r_{1}+r_{2}+\ldots+r_{n-1}\right) /(n-1)$ as the mean curvature radius of $x$. Let $\tau: U \mathbb{R}_{0}^{n} \rightarrow U \mathbb{R}^{n}$ be the Laguerre embedding defined by (20) and $\left(x^{\prime}, \xi^{\prime}\right)=\tau \circ(x, \xi)$. We get a hypersurface $x^{\prime}: M \rightarrow \mathbb{R}^{n}$. By a direct calculation we can show that

Y=\rho(\langle x, \xi\rangle-\langle x, \xi\rangle, \xi)=\rho^{\prime}\left(x^{\prime} \cdot \xi^{\prime},-x^{\prime} \cdot \xi^{\prime}, \xi^{\prime}, 1\right)=Y^{\prime}
$$

\begin{aligned}
& \eta=\left(\frac{1}{2}(1+\langle x . x\rangle), \frac{1}{2}(1-\langle x . x\rangle), x\right)+r(\langle x, \xi\rangle,-\langle x, x \xi\rangle, \xi) \\
& =\eta^{\prime}=\left(\frac{1}{2}\left(1+\left|x^{\prime}\right|^{2}\right), \frac{1}{2}\left(1-\left|x^{\prime}\right|^{2}\right), x^{\prime}, 0\right)+r^{\prime}\left(x^{\prime}, \xi^{\prime},-x^{\prime} \cdot \xi^{\prime}, \xi^{\prime}, 1\right)
\end{aligned}
$$

where $\rho^{\prime 2}=\sum_{i}\left(r_{i}^{\prime}-r^{\prime}\right)^{2}$ and $\rho^{2}=\sum_{i}\left(r_{i}-r\right)^{2}$. Thus the Laguerre metric is given by

g=\rho^{2} I I I=\rho^{\prime 2} I I I^{\prime}=g^{\prime}
$$

where III and III' are the third fundamental forms of $x$ and $x^{\prime}$, respectively.
We define $\tilde{E}_{i}=r_{i} e_{i}, 1 \leq i \leq n-1$, then $\left\{\tilde{E}_{1}, \tilde{E}_{2}, \ldots, \tilde{E}_{n-1}\right\}$ is an orthonormal basis for $I I I=d \xi \cdot d \xi$. Then $\left\{E_{i}=\rho^{-1} \tilde{E}_{i} \mid 1 \leq i \leq n-1\right\}$ is an orthonormal basis for the Laguerre metric $g=\langle d Y, d Y\rangle$, and we write $\left\{\omega_{1}, \omega_{2}, \ldots, \omega_{n-1}\right\}$ for its dual basis. By direct calculation, the basis Laguerre invariants $\mathbf{B}, \mathbf{L}$ and $\mathbf{C}$ of $x: M \rightarrow \mathbb{R}_{0}^{n}$ have the following local expressions:

& L_{i j}=\rho^{-2}\left\{\operatorname{Hess}_{i j}(\log \rho)-\tilde{E}_{i}(\log \rho) \tilde{E}_{j}(\log \rho)+\frac{1}{2}|\nabla \log \rho|^{2} \delta_{i j}\right\} \tag{23}

where Hess $_{i j}$ and $\nabla$ are Hessian matrix and the gradient with respect to $I I I=d \xi \cdot d \xi$.
Now we prove that $\nabla \mathbf{B}=0, \mathbf{L}=0$ and $\mathbf{C}=0$. We define $\xi$ as follows

\xi=\left(-\frac{\left|\lambda_{1} u_{1}\right|^{2}+\ldots+\left|\lambda_{s} u_{s}\right|^{2}-1}{2}, \lambda_{1} u_{1}, \lambda_{2} u_{2}, \ldots, \lambda_{s} u_{s},-\frac{\left|\lambda_{1} u_{1}\right|^{2}+\ldots+\left|\lambda_{s} u_{s}\right|^{2}+1}{2}\right) .
$$

Clearly $\xi$ satisfies the following conditions

$$
\langle\xi, d x\rangle=0, \quad\langle\xi, \xi\rangle=0, \quad\langle\xi, v\rangle=1 .
$$

By a direct calculation we know that the eigenvalues of $S$ are $\lambda_{1}, \lambda_{2}, \ldots, \lambda_{s}$ with multiplicity $m_{1}, m_{2}, \ldots, m_{s}$, respectively.

Set

$$
r_{i}=\frac{1}{\lambda_{i}}, r=\frac{1}{n-1}\left(r_{1}+r_{2}+\ldots+r_{n-1}\right) .
$$

From (22), (23) we get the Laguerre invariants of $x$ given by

$$
\begin{gathered}
\rho^{2}=\sum_{i}\left(r_{i}-r\right)^{2}=\text { constant, } \quad C_{i}=0, \quad L_{i j}=0, \quad 1 \leq i, j \leq n-1, \\
B_{i j}=b_{i} \delta_{i j}, 1+m_{1}+\ldots+m_{i-1} \leq i, j \leq 1+m_{1}+\ldots+m_{i-1}+m_{i} .
\end{gathered}
$$

where $b_{i}=\frac{r_{i}-r}{\sqrt{\sum_{i}\left(r_{i}-r\right)^{2}}}$.
Thus from (12) we get that $x$ is flat with respect to $g$, i.e.,

$$
R_{i j k l}=0,1 \leq i, j, k, l \leq n-1 .
$$

and the Laguerre second fundamental form $\mathbf{B}=B_{i j} \omega_{i} \otimes \omega_{j}$ of $x$ is parallel.

## 4. The proof of mian theorem

Firstly, we state the following result which is needed in the proof of main Theorem.
Lemma 4.1. Let $x: M \rightarrow R^{n}$ be an umbilical free hypersurface with non-zero principal curvatures. Then we have

$$
\begin{equation*}
|\nabla \mathbf{B}|^{2}+(n-1) \operatorname{tr}(\mathbf{B}(\nabla \mathbf{C}))-(n-1) \operatorname{tr}\left(\mathbf{L} \mathbf{B}^{2}\right)-\operatorname{tr} \mathbf{L}=0 \tag{24}
\end{equation*}
$$

where we denote

$$
|\nabla \mathbf{B}|=\sum_{i, j, k} B_{i, k, k}^{2} \operatorname{tr}(\mathbf{B}(\nabla \mathbf{C}))=\sum_{i, j} B_{i j} C_{j, i,}, \operatorname{tr}\left(\mathbf{L} \mathbf{B}^{2}\right)=\sum_{i, j, k} L_{i j} B_{j k} B_{k i} .
$$

Proof. By definition, we have

$$
\frac{1}{2} \Delta\left(\sum_{i, j} B_{i j}^{2}\right)=\sum_{i, j, k} B_{i j, k}^{2}+\sum_{i, j, k} B_{i j} B_{i j, k k}
$$

which is equivalent to

$$
\begin{equation*}
\sum_{i, j, k} B_{i j, k}^{2}+\sum_{i, j, k} B_{i j} B_{i j, k k}=0 . \tag{25}
\end{equation*}
$$

The second covariant derivative of $B_{i j}$ is defined by

$$
\begin{equation*}
\sum_{l} B_{i j, k l} \omega_{l}=d B_{i j, k}+\sum_{l} B_{l j, k} \omega_{l i}+\sum_{l} B_{i l, k} \omega_{l j}+\sum_{l} B_{i j, l} \omega_{l k} . \tag{26}
\end{equation*}
$$

We have the following Ricci identities,

$$
\begin{equation*}
B_{i j, k l}-B_{i j, l k}=\sum_{m} B_{m j} R_{m i k l}+\sum_{m} B_{i m} R_{m j k l} . \tag{27}
\end{equation*}
$$

On the other hand, using (10), (26) and ((27), a standard calculation gives

$$
\begin{aligned}
B_{i j, k k} & =\left(B_{i k, j}+C_{j} \delta_{i k}-C_{k} \delta_{i j}\right)_{k}=\left(B_{i k, j k}+C_{j, k} \delta_{i k}-C_{k, k} \delta_{i j}\right) \\
& =B_{i k, k j}+\sum_{l} B_{l k} R_{l i j k}+\sum_{l} B_{i l} R_{l k j k}+C_{j, k} \delta_{i k}-C_{k, k} \delta_{i j} \\
& =B_{k k, i j}+\sum_{l} B_{l k} R_{l i j k}+\sum_{l} B_{i l} R_{l k j k}+C_{i, j} \delta_{k k}-C_{k, j} \delta_{k i}+C_{j, k} \delta_{i k}-C_{k, k} \delta_{i j}
\end{aligned}
$$

From (11), (12) and the above equation, we easily obtain

$$
\begin{aligned}
\sum_{i, j, k} B_{i j} B_{i j, k k} & =\sum_{i, j, k, l} B_{i j} B_{l k} R_{l i j k}+\sum_{i, j, k, l} B_{i j} B_{i l} R_{l k j k}+(n-1) \sum_{i, j} B_{i j} C_{j, i} \\
& =\sum_{i, j, k, l} B_{i j} B_{l k}\left(L_{i j} \delta_{l k}+L_{l k} \delta_{i j}-L_{l j} \delta_{i k}-L_{i k} \delta_{l j}\right) \\
& +\sum_{i, j, k, l} B_{i j} B_{i l}\left(L_{k j} \delta_{l k}+L_{l k} \delta_{k j}-L_{l j} \delta_{k k}-L_{k k} \delta_{l j}\right)+(n-1) \sum_{i, j} B_{i j} C_{j, i} \\
& =-(n-1) \operatorname{tr}\left(\mathbf{L} \mathbf{B}^{2}\right)-\operatorname{tr} \mathbf{L}+(n-1) \operatorname{tr}(\mathbf{B}(\nabla \mathbf{C}))
\end{aligned}
$$

Inserting the above into (25), we get (24).
Lemma 4.2. Let $x: M \rightarrow R^{n}$ be an umbilical free hypersurface with non-zero principal curvatures. If the Laguerre second fundamental form is parallel and the Laguerre tensor is isotropic ( $\mathbf{L}=\lambda \mathbf{g}$, where $\lambda$ is a function), then $\lambda=0$ and $M^{n-1}$ is laguerre equivalent to the images of $\tau$ of the hypersurface $\tilde{x}$ in $R_{0}^{n}$ with mean curvature radius $r=0$ and $\rho=$ constant .

Proof. From (12) and $\nabla \mathbf{B}=0$, we obtain $\mathbf{C}=0$, and hence $\nabla \mathbf{C}=0$. From the formula (24), we obtain

$$
\begin{equation*}
-(n-1) \lambda \operatorname{tr}\left(\mathbf{B}^{2}\right)-(n-1) \lambda=0 \tag{28}
\end{equation*}
$$

Noting that $\operatorname{tr}\left(\mathbf{B}^{2}\right)=\sum_{i, j}\left(B_{i j}\right)^{2}=1$, we obtain $\lambda=0$. Hence

$$
\begin{equation*}
|\nabla \mathbf{B}|=0, \quad \mathbf{L}=0, \quad \mathbf{C}=0 \tag{29}
\end{equation*}
$$

By the classification theorem in [4], we know that $M^{n-1}$ is laguerre equivalent to the images of $\tau$ of the hypersurface $\tilde{x}$ in $R_{0}^{n}$ with mean curvature radius $r=0$ and $\rho=$ constant, given by the example 3.1.

The proof of the main theorem. Let $P$ be an arbitrary point in $M$. Since the $(n \times n)$-matrix $\left(L_{i j}\right)$ is a real symmetric matrix, we can choose orthonormal basis such that $\left(L_{i j}\right)=\lambda_{i} \delta_{i j}$ at $P$, where $\lambda_{i}$ are the eigenvalues of the $(n \times n)$-matrix $\left(L_{i j}\right)$ at $P$. From the formula (24), $\nabla \mathbf{C}=0, \operatorname{tr}\left(\mathbf{L B}^{2}\right)=\sum_{i, j} \lambda_{i}\left(B_{i j}\right)^{2}$, $\operatorname{tr}\left(\mathbf{B}^{2}\right)=\sum_{i, j}\left(B_{i j}\right)^{2}=1$. If the Laguerre tensor $\mathbf{L}$ is non-positive, then $\lambda_{i} \leq 0$, hence and

$$
\begin{equation*}
0=|\nabla \mathbf{B}|^{2}-(n-1) \sum_{i, j} \lambda_{i}\left(B_{i j}\right)^{2}-\sum_{i} \lambda_{i} \geq|\nabla \mathbf{B}|^{2}-2(n-1) \max \left\{\lambda_{i}\right\} \geq|\nabla \mathbf{B}|^{2} \geq 0 \tag{30}
\end{equation*}
$$

and so $|\nabla \mathbf{B}|=0$. Hence $\mathbf{C}=0$, and the equality must hold every where in (30) by the arbitrariness of point $P$. Then $\lambda_{i}=0$, i.e., $L=0$. Similarly, when the Laguerre tensor $\mathbf{L}$ is nonnative, we can get the same results. By the lemma 3.2, $M^{n-1}$ is laguerre equivalent to the images of $\tau$ of the hypersurface $\tilde{x}$ in $R_{0}^{n}$ with mean curvature radius $r=0$ and $\rho=$ constant, given by the example 3.1. This completes the proof.
